

Eagle Federal Credit Union
June 30 Giveaway Contest Official Rules

1. Eligibility: No purchase or obligation necessary to participate and win. Registering contest participants must be Credit Union members. All participants must be 18 years of age or older at time of contest participation. Employees of Eagle Federal Credit Union (“Credit Union”), their immediate families (spouses, parents, children and siblings, and each of their respective spouses), and members of the household of such individuals are not eligible to register for the contest.
2. How to Enter the Contest. The Contest begins at 12:01am Central Time (“CT”) on May 1, 2019 and ends 5:00pm CT June 30, 2019. Contest may be terminated at any time.
3. A Member may enter the contest with one entry by applying for a vacation loan prior to the end of the contest (“10 Chances to win Free Carry-On.”)
4. A Member may also enter the contest by completing the online registration and mailing to: Eagle Federal Credit Union, ATTN: Marketing, P.O. Box 64630, Baton Rouge, LA 70808. Must be postmarked by June 20, 2019.
5. Credit Union will not be responsible for incomplete, lost, late, misdirected or illegible entries or for failure to receive entries. All entries become property of Credit Union and none will be returned. Any questions regarding the number of entries submitted shall be determined by Credit Union in its sole discretion, and Credit Union reserves the right to disqualify any entries by persons determined to be tampering with, violating, or abusing any aspect of the contest.
6. Contest Entry Requirements: In the event the Credit Union, in its sole discretion, determines that any Entry contains content that does not comply with these Official Rules or does not otherwise comply with regulatory guidelines, Credit Union reserves the right to disqualify the entry.
7. Determining the Winner: A Credit Union employee will select at random one winner for the Free Carry-on once a week till 10 winners have won by 5:00pm CT June 30, 2019. The winners of the drawing will be revealed by phone or email or on Facebook.
8. Prizes: 1 of 10 Carry-ons. Prizes are non-transferable.
9. A Credit Union employee will call the Carry-On prize winner and leave a message for a return call, during regular business hours at numbers provided on entry form or on membership. Failure to reach winner during these calls may result in disqualification of winner, forfeiture of his or her interest in all prizes, and selection of a substitute winner drawn. Winner will be required to complete and sign an affidavit of eligibility and a liability and publicity release. Failure of any Winner to timely sign and return any required affidavit and release, or to claim a prize or comply with any term or condition of these Official Rules, will result in drawing Winner's disqualification and the forfeiture of his or her interest in the prize. Winners may waive their right to receive prizes. Prizes are non-assignable and nontransferable. No substitutions allowed

by winner. Prizes and individual components of prize packages are subject to availability and the Credit Union reserves the right to substitute prizes of equal or greater value.

10. Participation. By participating, entrants agree to be bound by these Official Rules and the decisions of the Contest. Except where prohibited, acceptance of any prize constitutes winner's consent to the publication of his or her name, biographical information and likeness in any media for any commercial or promotional purpose, without limitation the Internet, or further compensation. Prizes not won and claimed by eligible winners in accordance with these Official Rules will not be awarded and will remain the property of the Credit Union.
